REMINDER

Respected Sir,

Re: Non-Release of PF accumulation of staff of RRBs.

We had earlier addressed communications to your good office on the 8th and 24th of June, 2021, on the subject of exclusion of the staff of RRBs from the ambit of Employees' Provident Fund Act of 1952 consequent upon the verdict of the Supreme Court on the 25th of April, 2018, declaring them eligible for pension as prevalent in nationalised commercial banks.

We had further appealed to your good self for kind intervention for ensuring that the PF accumulation of the staff of the RRBs, hitherto retained with the RPFs, was expeditiously released to the individual RRBs for refund to the staff, etc.

We would like to draw your kind attention the plight of the staff of the RRBs, who, on retirement, are not receiving the PF dues, and moreover, have to refund upfront, the sums they would have received as employers' contribution, for release of pension as per banking industry norms. This double jeopardy is a devastating blow to the retirees.

May we urge upon your good self to look into this humanitarian issue and arrange to instruct the RPFs to remit the PF accumulation of RRB staff forthwith and thus extricate the hapless retirees of RRBs from this grim ordeal.
