

# <u>Letter to Shri Sunil Arora, The Chief Election Commissioner of India for</u> Clearance of pending 11<sup>th</sup> Salary Revision to RRBs

### Sub: - Clearance of pending 11th Salary Revision to RRBs.

The 8<sup>th</sup> Joint Note of 11<sup>th</sup> Salary Revision for officers of Public Sector Banks was signed with IBA and four Officers' Associations of Public Sector Banks on 11<sup>th</sup>November 2020. Thereafter, IBA had sent it to the Department of Financial Services for approval. The Dept. of Financial Services had accorded its approval of the salary revision and sent it to the Public Sector Banks for immediate implementation in the month of December 2020.

According to the verdict of The Hon'ble Supreme Court and the Award of National Industrial Tribunal established under its aegis for deciding upon salary, allowances and

perquisites of officers and employees of Regional Rural Banks, any revision in salary and allowances of officers and employees in the Public sector Banks would per se be extended to the employees and officers of the RRBs within a reasonable period of time.

In this regard, we have learnt from reliable sources that the Dept. of Financial Services of the Union Finance Ministry has forwarded its ratification and approval of the proposal for implementation of the  $11^{\rm th}$  Salary Revision in the Regional Rural Banks to your good office seeking clearance in view of elections in 5 states.

With due respect we would like to draw your kind attention to the fact that the salary revision is already long overdue and moreover this forms a part of an ongoing process begun long before elections were declared.

In view of the above, we would request your kind self to grant clearance to the above at your earliest convenience to provide much-awaited relief to the staff of the RRBs.
